Boarding Contract & Release

This is a contract between Kiki's K-9 Kennels, LLC dba Doggie Dude Ranch and Cat Farm, hereinafter called The Ranch, and _____ (Pet owner's name), hereinafter called the Owner, in reference to the Owner's pet(s), and hereinafter called the Pet.

The Owner understands that the Ranch, its owner(s), employees, and agents will exercise due care to protect the health and safety of the Pet while in their care, and that in the event that the Pet becomes ill or sustains an injury the Ranch is hereby authorized in its discretion to call the veterinarian designated by the Owner. If the Owner has not informed the Ranch of the name of the veterinarian, or if the designated veterinarian cannot be contacted, and the in the opinion of the Ranch the Pet requires prompt medical attention, the Ranch is authorized to call a veterinarian of its choice, or to give other advisable attention within the discretion of the Ranch and such expense being reasonable in amount shall be paid promptly by the Owner.

Should the Pet get ill or injured, the veterinarian and Ranch will use the following guidelines as agreed by the Owner; the owner gives the staff at the Ranch permission to seek medical treatment and/or disposal if death occurs.

The Owner understands that during boarding, participating in Doggie Daycare, and/or in Playtime activities, and during grooming that the Pet will interact with people and/or other pets. As always, with the interaction of the Pet, people, and other pets, there is a chance of injury. Owner understands that all reasonable precautions against injury, escape, or death of the animal during boarding, doggie Daycare, Playtimes, or Grooming shall be undertaken, but will not hold the Ranch, its owner(s), or its staff liable or responsible in any manner what so ever, or any circumstances, on account of the care, treatment, or safe keeping of the pet, or otherwise in connection therewith, as it is thoroughly understood that the Owner assumes all risks.

The Ranch agrees to exercise due and reasonable care, and to keep the facilities and premises sanitary and properly enclosed. The Pet is to be fed properly and regularly, housed in clean, safe quarters and properly supervised during Doggie Daycare and/or Playtime. On occasion the Ranch will respond to a community need to house guests requiring special handling and care involving illness, quarantine, or behavior concerns. The Ranch will take all due precautions when such needs arise to prevent exposure or interaction with such guests.

The Owner understands that all pets showing signs of fleas or ticks will be bathed and dipped and agrees to pay for such expenses.

All charges incurred by Owner shall be payable upon pickup of the Pet.

It is understood by the Ranch and Owner that all provisions of the Contract shall be binding upon both parties thereunto for this visit and for all subsequent visits, unless the contract is terminated by either party at any time by giving written notice in person or by registered mail. The owner certifies that they have read and understands this Contract. The Owner agrees to abide by the rules and regulations and accept all terms, conditions, and statements of this Contract and is aware that by signing this contract they are stating that they have provided all vital information about their pet and said pet is up to date on all necessary vaccinations. This Contract contains the entire agreement between the parties.
